St. Joseph Hospital opened its doors on September 16, 1929 as the largest and most modern hospital in the area due to a growing need for health care in Orange County. With a 50-member medical staff and 190 beds, it echoed the vision of the founding Sisters of St. Joseph of Orange as being “the last word in magnificence and technology.” That vision has guided our ministry to achieve excellence throughout the years — from medical and technological firsts to recognition as a leader on the local, regional and national health care stage.

This year we celebrate our ministry’s 90th anniversary, a milestone that provides us an opportunity to reflect on our past, celebrate the present and commit ourselves to the future. A commemorative logo has been developed and will be incorporated into our communications for the remainder of the year to help heighten awareness of this important milestone. It was designed in reflection of our legacy of providing compassionate care to our community for nine decades, dating back to the original hospital building dedicated by the Sisters of St. Joseph of Orange in 1929. This facility, known today as the Sister Frances Dunn Building, continues to be an integral part of our culture.

Though many changes have taken place since 1929, one thing has remained the same: the dedication of our medical staff, caregivers, volunteers and community supporters. Because of you, we have become a ministry that responds to the changing health care environment, continually strives to meet the current and future needs of our patients, and honors and enhances our legacy of caring. Your support enables us to continue to provide high-quality, compassionate care to thousands of people every day, while creating a culture of excellence within every department, service and program.

We are proud to continue the rich heritage of the Sisters of St. Joseph of Orange by building on our legacy of providing care with compassion, dignity, justice, excellence and integrity. I am often reminded of Mother Bernard’s poetic words that are etched into the glass walls that surround the Patient Care Center: “I pray that you might find light, joy, and consolation to assist and serve the dear neighbor with an orientation toward excellence.” I thank you for your ongoing efforts and for your continued support in the future as we look forward to our next 90 years of healing.

Celebration 2018 In Memory of Ron Moeller

Presented by Centaurus Financial, Inc., the Gooding-Barry & Immell Families and Satellite Management Company, Celebration 2018 raised over \$575,000 for the St. Joseph Hospital cancer navigator program, cancer research program and new linear accelerator at The Center for Cancer Prevention and Treatment.

More than 530 guests attended Celebration, the hospital's annual fundraising gala, at the City National Grove of Anaheim on Saturday, October 13. Attendees enjoyed a night of fine dining, silent and live auctions, a raffle drawing for a Chevy Equinox presented by Guaranty Chevrolet, and a live performance by the online musical phenomenon Postmodern Jukebox.

The annual Spirit of St. Joseph Award, which honors donors who

embody the spirit of St. Joseph in their generous work and who have demonstrated a long-term commitment to the hospital and its values, was presented to Kathy and Jim Gough, and Diana and David Margileth, MD.

This event marks the first time that the gala's proceeds exclusively benefitted The Center for Cancer Prevention and Treatment at St. Joseph Hospital, which is the first center of its kind in Orange

County to offer diagnostic screening, preventive services, clinical research and cancer treatment in one location.

Event Co-Chair and long-time hospital supporter Marsha Moeller shared why she continues to raise awareness about cancer and the importance of philanthropy after losing her husband Ron Moeller to lung cancer in 2016. "After his diagnosis in 2010, Ron made it his mission to help fund critical services

for The Center for Cancer Prevention and Treatment at St. Joseph Hospital. Not only did the hospital help Ron and our family battle cancer for more than six years, but they offered the best care and treatment in our community. Cancer touches so many lives and that's why we want to do what we can to help St. Joseph Hospital continue to offer the latest and greatest in medicine and technology," said Moeller.

Community Clinic Starts a New Chapter

St. Joseph Hospital established its first community clinic, La Amistad de Jose Family Health Center, in 1986. This was due to the Sisters of St. Joseph of Orange's ongoing commitment to eliminate barriers to care for the most vulnerable members of our community and provide them with top quality medical, dental and vision services.

Since that time, St. Joseph Hospital has continued to adapt and expand our clinic programs to ensure a strong and comprehensive safety net for low-income, underinsured and uninsured individuals in our community. For example, Puente a la Salud Mobile Community Clinics were added in 1996, allowing our caregivers to provide services directly in the communities where individuals live and work.

St. Joseph Hospital just celebrated yet another milestone in October 2018 — the Grand Opening of the new La Amistad Health Center at the Batavia Woods complex in Orange. The renovated 11,000 square-foot space is nearly three times larger than the original clinic on Main Street and will allow us to serve more people.

Several Sisters, community leaders, caregivers, volunteers and philanthropic supporters attended this joyful celebration. St. Joseph Hospital Chief Executive Jeremy Zoch, PhD, MHA, FACHE, welcomed guests and shared a few words about the history and future of the clinic. Bishop Thomas blessed the new facility and the programs.

Surgical Innovations

da Vinci® Robotic Reception and Lecture

A travelling da Vinci® Robotic Surgical System made an appearance at the St. Joseph Hospital Center for Cancer Prevention and Treatment on January 30. The da Vinci X is the latest model to be added to St. Joseph Hospital's Robotic Surgery Program. More than 65 generous donors, physicians and caregivers attended this engaging reception and lecture.

Participants were excited to experience for themselves the highly magnified and immersive 3D, high-definition visualization of the robotic system. Sitting at the control console, they “operated” with tiny wristed instruments, picking up miniature colored rubber rings and maneuvering them to simulate the fine motor control and dexterity the surgeon experiences during robotic-assisted surgery. They learned that the robot does not perform the surgery, but rather translates motions from the surgeon’s fingers to the instruments with high precision and eliminates any tremors from the surgeon’s hand.

A panel of St. Joseph Hospital surgeons who specialize in robotic surgery described how they use this technology in each of their medical specialty areas and how it improves patient care. The panel included Robotic Surgery Program Director Abtin Khosravi, MD, general surgery; Brian Palafox, MD, thoracic surgery; Janis Fee, MD, gynecology; and Brian Norouzi, MD, urology.

The presenters spoke about the benefits of robotic-assisted, minimally invasive surgery for patients, which include less blood loss, less scarring, reduced risk of infection and complications, shorter hospital

stays, faster recovery and less pain than traditional surgical approaches.

“The robot not only helps surgeons achieve better surgical outcomes, it also helps reduce strain, especially on the back, neck, shoulders and knees, by allowing surgeons to operate while seated comfortably in an ergonomic position. This has the potential to extend the careers of some very experienced and highly competent surgeons,” explained Dr. Palafox.

Dr. Khosravi provided insight into the rapid growth of robotic-assisted surgery as well as exciting breakthrough technologies on the horizon.

Heidi Daniel, RN, manager of St. Joseph Hospital's Bariatric and Robotic Surgery Programs

concluded the event. “I want to express sincere gratitude and recognition to our faithful donors, whose generosity makes it possible to bring technology to the forefront of health care; and also to members of our medical staff who care tremendously about the patients they serve here at St. Joseph Hospital.”

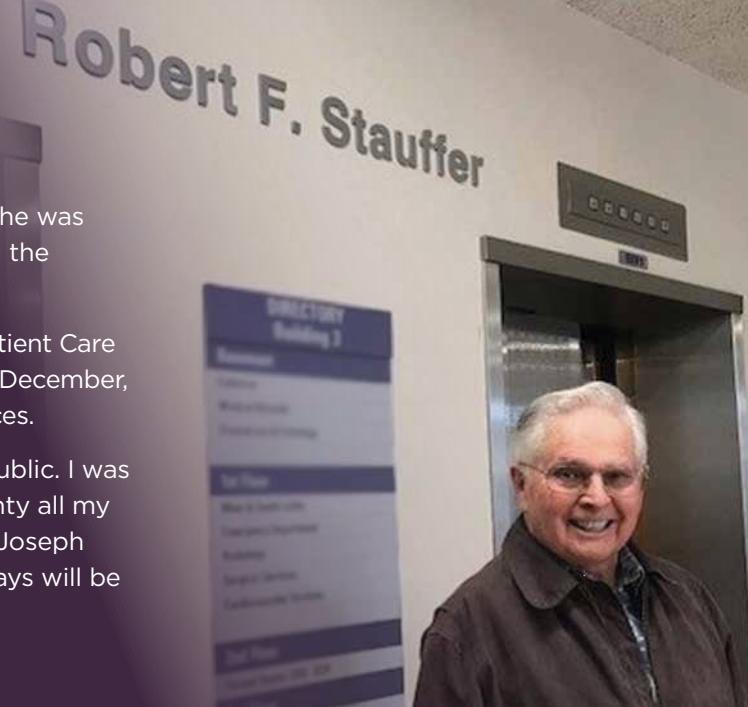
