Rina Santora, RN Memorial Scholarship for Nursing

When Rina Santora died in June, 2018 after a heroic 5 1/2 year fight with pancreatic cancer, her family did something very typical of Rina's character – reached out to care for others. Dr. Lawrence Santora, a well-known cardiologist, and his family founded an endowed scholarship in Rina's memory to help nursing students pursue their education.

The Rina Santora, RN Memorial Scholarship is for professional advancement in nursing, with a primary focus on helping St. Joseph Hospital staff who are in a nursing program (RN or BSN).

Rina's first love was being a wife, mother and grandmother. Her second love was being a nurse. She received her nursing degree from Cypress College, and bachelor's degree from Chapman University. She had a significant impact on health care in Orange County and affected the lives of thousands of patients. Rina helped develop the first "Heart Center", a new outpatient-testing concept in 1990, and the Women's Heart Center at St. Joseph Hospital. She also worked as a nurse at the Dick Butkus Center for Cardiovascular Wellness at St. Joseph Hospital, counseling patients on cardiac wellness and coronary CT scans.

Rina lived life with compassion, grace and dignity. She never once asked "Why me?", but always asked, "What can I do to help others?" She was forever a nurse and mother to her last breath. Her family continues her legacy with the *Rina Santora, RN Memorial Scholarship for Nursing*.

Medication-Assisted Treatment (MAT) Program Grant for Patients with Opioid Use Disorders

St. Joseph Hospital was recently awarded a \$434,000 grant from the Sierra Health Foundation funded through California's Department of Health Care Services' MAT Access Points Project.

This grant will support our efforts to effectively treat more patients with opioid and other substance use disorders, helping them achieve improved health and long-term recovery.

St. Joseph Hospital's comprehensive Substance Abuse and Recovery Management Program provides counseling and behavioral therapies coupled with FDA-approved medication treatment a proven strategy for decreasing opioid use and associated deaths. Assisting patients with smooth transitions to appropriate post-treatment medical care and support in the community is an important program component.

Joan and Harry Hansen \$3.4 M Legacy Gift

It was with the help and consideration of Joan and Harry Hansen's extraordinary legacy gift to St. Joseph Hospital that the impressive Center for Cancer Prevention and Treatment opened in 2008.

In 2007 the Hansens established a charitable remainder unitrust (CRUT) which provided them with income as grantors/beneficiaries and the remainder of the trust to SJO after their lives. The variable income is based on a percentage of the fair market value of the assets in the trust. A CRUT is usually funded with a valuable asset such as real estate, stocks, bonds and other property.

Mr. Hansen passed in 2014 leaving Mrs. Hansen as the beneficiary of the CRUT until she passed in late 2018. "Joni" — as Mrs. Hansen was more fondly known — was a vibrant women with a sharp mind, quick wit and a ready smile. She loved life and people. Mr. and Mrs. Hansen's legacy gift was made in memory of their late son, Kirk, who was treated for cancer at St. Joseph Hospital.

DID YOU KNOW?

St. Joseph Hospital recently reached \$50 million towards our \$75 million community campaign.
