LINEAR ACCELERATOR GRANT FROM GUENTHER



Varian TrueBeam® Linear Accelerator

Many thanks to the Henry L. Guenther Foundation whose \$2 million grant has provided us with an exceptional start towards raising the \$4.5 million dollars needed to purchase and install a new Varian TrueBeam® Linear Accelerator. This new machine and its leading-edge technology will help us achieve better treatment outcomes for both adult and children, improve safety, improve patient comfort, and lower treatment costs.

The advances of the TrueBeam allow for superior tumor destruction, utilizing higher doses of radiation, while reducing impact on the healthy tissue surrounding the tumor. This new method will also help to reduce the number of treatments a patient may need — in some cases from around 40 down to five.

The new system also tracks tumor movement such as patient’s breathing. If the tumor moves out of the beam’s field, the beam automatically shuts off to prevent irradiation of healthy tissues.

RON AND CAROL THON MAKE A GENEROUS GIFT THROUGH AN IRREVOCABLE CHARITABLE REMAINDER UNITRUST

As a new member of the Foundation Board, Ron Thon wanted to make a gift to the hospital and take advantage of a matching gift opportunity.

A few years ago, Ron and Carol Thon created a Charitable Remainder Unitrust (CRUT). The CRUT was funded with appreciated property. This strategy allowed them to sell the appreciated property in the Trust without incurring capital gains tax and at the same time receive a charitable income tax deduction. The Thons will receive income from the Trust for the rest of their lives. Upon their passing, the assets in the Trust will be distributed to St. Joseph Hospital.

Some Charitable Remainder Trusts allow for the donor to change the charitable beneficiary at any time. The Thons changed their Trust by making a portion of the Trust irrevocable to St. Joseph Hospital Foundation. With this change, the gift could be counted as a current donation and be doubled with the matching gift.
