## JIM AND KATHY GOUGH USE A SAVVY PLANNED GIVING STRATEGY TO BENEFIT ST. JOSEPH HOSPITAL WITHOUT GIVING UP THEIR RETIREMENT INCOME

After retirement, Jim Gough answered a volunteer advertisement from St. Joseph Hospital. He came to love the hospital and the people so much that Kathy began volunteering as well.

Recently, Jim and Kathy began speaking to Phil Barker, Director of Gift Planning, about strategies that would be best suited for them. The Goughs held a partnership interest in an apartment complex and they felt that it was time to move out of the investment. With Phil's help, Jim and Kathy chose a Charitable Remainder Flip Trust. The interest was transferred to the trust which allowed them to receive a charitable income tax deduction for the value and they continue to receive the rent income from the complex. Looking ahead, when the complex sells the proceeds will go into the trust, avoiding capital gains taxes. It will be reinvested for continued growth while Jim and Kathy receive unitrust income payments quarterly for the rest of their lives.
