

BREAKING GROUND ON THE FUTURE

Construction on the new Helen Caloggero Women's and Family Center is underway

The future of women's health care is taking shape at Providence St. Joseph Hospital.

On September 21, crews broke ground on the Helen Caloggero Women's and Family Center, marking the culmination of years of planning and fundraising for this unique facility that will offer the full spectrum of health care for women.

Named after Marsha Moeller's late mother, whose generosity was key to making this project a reality, the building will be the first of its kind, featuring services and amenities focused on women and families.

"It is an exciting time for women in our community," shares Michelle Genova, MSN, RNC-OB, chief nursing officer at Providence St. Joseph. "The new center will truly ease the way for our patients with innovative technology, new options for maternity care, convenient access to excellent physicians and certified nurse midwives."

Slated to open in 2023, the advanced four-story facility will rise at the corner of Main Street and Stewart Drive, providing a centralized location for maternity services, imaging, maternal mental health counseling, a pharmacy and more.

One of the center's unique features is a freestanding natural birth center, providing mothers with individualized care in a welcoming, homelike setting. Staffed by midwives and

doulas, the natural birth center will facilitate labor and birth experiences for women and their partners, enhanced by the safety of the hospital campus. The adjacent Midwife Clinic will offer prenatal care and follow-up appointments.

The facility will also include the Center for Pelvic Health, Stork Stop maternity boutique, a graband-go cafe and several other medical offices.

The new Helen Caloggero Women's and Family Center represents a significant investment in the community to help ensure the health of local mothers and children for years to come.

"As women are caring for their families and communities, we want to care for them," says Sister Thuy Tran of the Sisters of St. Joseph of Orange. "Investing in women's health today will mean a healthier tomorrow for future generations."

Michelle agrees. "We've always placed patient care as the top priority," she says, "But the commitment to women has been elevated by our investment in locating so many unique services for women under one roof."

Thanks to the generous support from our community, the key to that investment is possible.

"Philanthropy is the cornerstone for innovation. We appreciate the dedication of our hospital



donors. Without them, the mission and the vision of the Sisters would not be made real," said Michelle.

In the case of the Helen Caloggero Women's and Family Center, one donor stands out: longtime foundation supporter Marsha Moeller.

Inspired by her mother's giving spirit, Marsha's support spans from personally hosting fundraisers for Providence St. Joseph in her home to serving as the honorary chair of the annual Celebration event.

But her most enduring contribution might be her historic gift to fund her mother's namesake.

Marsha says she is honored to name the new facility after her mother, who passed when she

was only seven years old. "I think of her every single day," she explains. "I do feel like she's been very present in my life."

And now Marsha's mother will be a presence in the lives of the countless local mothers and children who receive care at our new facility. That gives Marsha a joy that she hopes others will share.

"It makes me happy to give," she says. "It makes me feel like I'm really contributing."

"A heart of gold"

A man of great faith and integrity, Edward Michael Linzey, MD, came to Providence St. Joseph Hospital in 1977 as an OB/GYN physician. Known for his ability to make each patient feel loved and cared for, he touched many lives during his 40 years at the hospital.

He helped bring close to 20,000 babies into the Providence St. Joseph community, and even inspired a Facebook group called "Dr. Linzey Delivered My Baby" with over 500 members. He helped establish the



LivingWell Clinic, Sweet Success Program for Maternal Diabetes and Maternal Fetal Testing Program in addition to serving as vice chair of the OB/GYN department.

ALL IN THE FAMILY

City of Orange family — and one special nurse — welcomes a fourth generation of Providence St. Joseph babies

When KaSondra Gonzalez gave birth to her second daughter, Dakota, at Providence St. Joseph Orange on July 25, she and her husband weren't only celebrating a healthy delivery. They were also carrying on a family tradition.

Dakota and her big sister Shyanne, now 16 months old, represent the fourth generation of the Carver family born at Providence St. Joseph.

The legacy began in 1938 with the birth of Donna Carver, who would go on to deliver six children at Providence St. Joseph: Christine, Michael, Mark, Carol, Kevin and Kenneth. Then, in 1990, Michael welcomed a daughter of his own, KaSondra, as well as son Austin, 17 months later. With the debut of Shyanne and now Dakota, Providence St. Joseph Hospital has become an even more deeply treasured part of the Carver family history.

"We've always been taken care of here," reflects KaSondra. "Every experience, every encounter we've had has been great. It's nice to have a personal relationship with these caregivers."

KaSondra's aunt, Carol Suchy, MSN, RN, IBCLC, is carrying on the family legacy in a different way as manager of the hospital's Mother-Baby Unit, as well as the Obstetrics High-Risk Unit.

Carol is delighted to have supported her niece as both a caregiver and a family member. "She was on my unit," says Carol. "I was there for her, and just as excited as they were to be a part of that special time in their lives." Their family has deep roots in the city of Orange and has long emphasized the value of supporting the community through Providence St. Joseph Hospital. Carol tells the story of her grandfather coming to Orange in 1919 and helping the Sisters of St. Joseph. Another family member was involved in putting the cross on the building.

For the two Carver women, that relationship is just as inspiring today as it was a century ago. "I feel like the work that the Sisters do is my mission," Carol says. "It's not a job. It's a vocation that I want to continue. I think that at Providence St. Joseph, the caregivers really believe in the mission."

Both KaSondra and Carol are enthusiastic about the new Helen Caloggero Women's and Family Center, breaking ground this year. The center will bring mother-baby services currently at nine different locations to one central unit.

"I'm the type of person that likes to go to doctor's appointments where I'm secure and safe, knowing that all my resources are in one place," says KaSondra.

Her aunt concurs, expressing her gratitude to Marsha and the other benefactors who made the new facility possible. "A big thanks for understanding the importance of this journey for women — making it the best possible experience and easing their way through this incredible time in their lives."

After all, they know from experience: It's a legacy that will last for generations to come.





MEET DRS. ALEX AND NEERJA ZAND

Husband and wife with deep family ties to Providence St. Joseph Hospital

For Drs. Alex and Neerja Zand, medicine is more than a career. It's a family affair.

Both were inspired early in life by watching their physician parents care for patients. They both have close relatives working as doctors at Providence St. Joseph Hospital. And their children were both born at the hospital.

They are truly part of the Providence St. Joseph Hospital family.

Although they have very different specialties — he focuses on adult medicine and geriatric care, while she is a pediatrician — they share a commitment to the culture and values that make Providence St. Joseph Hospital special.

"Providence St. Joseph is based on the most important principles of giving each human value and dignity," Dr. Neerja says. "Those are sometimes overlooked, but they have always held these tenets that I think are most important."

Her husband agrees: "At Providence St. Joseph, I've always felt that everyone's goal was to take care of the patient. It's more about service ... the culture of selfless behavior and caring for the community. That's something to be proud of."

That recognition of how important Providence St. Joseph Hospital is to the community inspired the Zands to serve as co-chairs of this year's fundraiser, Celebration 2021: Embracing a Healthy Tomorrow, From Our Home to Yours.

The Zands say that helping sustain the Foundation and giving back to the community is "part of the package" of being a physician. "It's an honor to be able to help," Dr. Neerja says.

Dr. Alex adds: "Philanthropy fills the gaps in our community by enabling Providence St. Joseph physicians to care for underserved populations and giving them the tools to address the most difficult health care challenges."

Providence's mantra "Health for A Better World" conveys a mission that the Zands believe in.

"Health doesn't happen by itself. It's a combination of mental health, physical health, environmental health. It all goes hand in hand to create a better, healthier community," Dr. Alex says.

That message resonates with Dr. Neerja in her work as a pediatrician: "For children, you have to start young, put them on the right track building good habits that lead to good health," she says. "Because the youth are our future."

Speaking of the future, the Zands say they hope to leave a positive legacy built on hope and love.

"We'd like to be remembered for giving help, love and care to family, friends and patients," Dr. Neerja says. "I think that's all we want. To give and have been loved."

If you own real estate, it is likely to be a substantial part of your personal wealth. Whether it is a personal residence, vacation home, business or rental property, there is no question real estate can become an extremely valuable asset over time. For this reason, real estate can play a strategic role in your legacy planning with a variety of flexible options to best fit your financial needs:



Bequest of Estate

An outright gift of real estate is a simple way to provide immediate support. Real estate held over one year avoids capital gains taxes and qualifies for a deduction equal to the full value of the property on the date of the gift.



Life Estate Reserved

Enables you to make a gift of your property while continuing to live there and qualifies for a current tax deduction based on the projected value of future property interest. An additional option is to use your property to fund a charitable gift annuity, allowing you to receive income for life while still qualifying for a charitable deduction.



Bargain Sale

When selling your property to us for less than its market value, it allows you to receive cash and qualify for a tax deduction; additionally, avoiding capital gains tax on the amount determined as a gift.



Charitable Remainder Annuity Trust/Unitrust

When you donate real estate through a CRT, your property is sold without incurring immediate capital gains tax and qualifies for a partial tax deduction. Sale proceeds are invested to create lifetime income for you or others or for a specified period of up to 20 years. When the income benefits end, the remaining assets are then donated.

The combination of avoiding capital gains and enjoying a tax deduction makes a gift of real estate a strategic way to meet charitable goals. TAX-FREE GIFT FROM YOUR IRA

If you are 70½ or over, a transfer directly from your IRA is a simple yet highly effective way to give:

- The amount transferred counts toward your required minimum distribution if one is due.
- You pay no income tax on the amount transferred.
- Transfers up to \$100,000 (annual aggregate amount) qualify for this favorable tax treatment each year.
- Make an immediate impact there is no need to wait until the end of the year.
